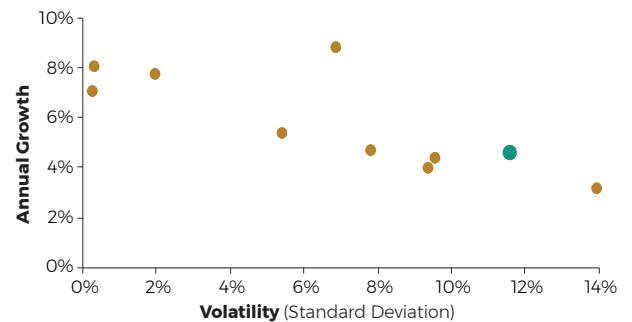

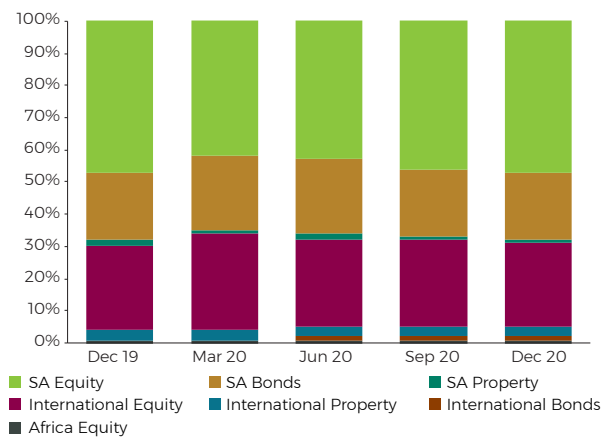

<b>Investor Profile</b>	The fund is ideal for long-term investors who do not want to manage their own asset allocation and believe in the benefit of investing with more than one manager.
<b>Investment Mandate</b>	The Fund may have maximum 75% exposure to equities and is by virtue of its aggressive balanced nature likely to have an average equity exposure higher than the exposure typically displayed by most other multi-asset high equity portfolios. Derivatives may be used for risk management purposes.

These are also the times we value our funds to determine the daily ruling price (other than at month-end when we value the Old Mutual Index Funds and Old Mutual Multi-Managers Funds of Funds range at 17:00 close). Daily prices are available on the public website and in the media.
- Unit trusts are traded at ruling prices, may borrow to fund client disinvestments and may engage in script lending. The daily price is based on the current market value of the fund's assets plus income minus expenses (NAV of the portfolio) divided by the number of units on issue.

- A fund of funds is a portfolio that invests in other funds which levy their own charges, which could result in a higher fee structure for the fund of funds.
